Due to the lack of use of the ambulance stationed in Laurens, representatives from the City of Laurens and Pocahontas Community Hospital are exploring ways to optimize the use of the ambulance stored in Laurens and enhance ambulance services across the county. We are proposing transferring the ambulance from Laurens to a different community in Pocahontas County. This is one last attempt to secure more staff who reside in the Laurens area and will be collecting comments and applications over the next six months to best assess how to move forward. The informational letter will be advertised in papers and will be posted on social media. No action was taken.
