

ORDINANCE #2021-01

AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF GILMORE CITY, IOWA 2011, BY AMENDING THE PROVISIONS PERTAINING TO WATER RATES

BE IT ORDAINED by the City Council of the City of Gilmore City, Iowa

SECTION 1. SECTION MODIFIED: WATER, Chapter 8.01-6A of the Code of Ordinance of the City of Gilmore City, Iowa, 2011, is hereby repealed, and the following adopted in lieu thereof.

8.01-6A. WATER RATES. Water shall be furnished at the following monthly rates per property serviced with the City Limits. (Code of Iowa, Sec. 384.84(1)).

- 1) Water Debt Service Charge: \$15.00 per month
- 2) Meter Charge: \$15.00 per month
- 3) First two thousand (2,000) gallons or lesser amount @ \$15.00 per month
- 4) All over two thousand (2,000) gallons or lesser amount @ \$7.50 per thousand (1,000) gallons

In no case shall the minimum service charge be less than \$45.00 per month, which is necessary for water system debt service, operating and maintenance costs, and reserves necessary for maintaining the water system. In addition, the City reserves the right to increase charges to offset the increase of expenses.

SECTION 2. SECTION MODIFIED: WATER, Chapter 8.01-8 of the Code of Ordinance of the City of Gilmore City, Iowa, 2013, is hereby repealed, and the following adopted in lieu thereof.

8.01-8. Chapter 99. Sewer Service Charges

- 1) Seventy percent (70%) of the bill of water and water service attributable to customer for the property served with the exception of the Water Debt Service Charge.

The City reserves the right to add a sewer debt service charge to offset the increase of expenses or the addition of sewer debt.

SECTION 3. SERVERABILITY CLAUSE: If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

SECTION 4. WHEN EFFECTIVE. This ordinance shall be in effect from and after its final passage, approval and publication as provided by law.
