

Rolfe Regular Re-Scheduled Council Meeting  
Wednesday June 23, 2021  
Rolfe Community Center, 5:30 p.m.

Mayor Tom Andersen called the rescheduled meeting to order at 5:41 p.m. Meeting was rescheduled from June 14<sup>th</sup> due to lack of quorum. Mayor took roll call. Council present Ryan Peters, Rick Jones, Kris Trenary and Carrie Frerk, absent Jon Wellik.

Peters/Jones moved to approve consent agenda including, agenda, and bills 5/10/21 minutes and building permit for Terri Kipfer. All ayes.

Discussion on tree trimming for west side of town. Jones/Peters moved to hire Travis Schoon to trim trees. All ayes.

Jones/Peters moved to approve Resolution #670 a resolution to transfer funds for fiscal yearend. Ayes: Peters, Jones, Trenary and Frerk.

Jones/Peters moved to approve Resolution #671 a resolution proposing the sale of Real Property in the City of Rolfe. Ayes: Peters, Jones, Trenary and Frerk.

Discussion on changing meeting times. No action taken.

Discussion on contracting out water/wastewater. Only need wastewater at this time. Jones/Frerik moved to get prices to contract out wastewater. Ayes: Peters, Jones, Trenary and Frerk.

Frerik/Jones moved to approve Resolution #672 a resolution to approve the wage for Tony Higgins. Ayes: Peters, Jones, Trenary and Frerk.

Council discussed applicants for WA/WW position. Other discussion. Trenary/Peters moved to set a wage range of \$18.00-20.00 a/hour depending on experience for wanted ad. All ayes.

Council directed clerk to set up applicant interviews for Monday June 28<sup>th</sup> to start at 5:30 p.m.

Council set a date for an ordinance workshop for July 19<sup>th</sup> at 5:30 p.m.
