Discussion on old Sunnybrook property. Peters/Jones moved to send a cleanup letter. All ayes. Mayor called to open the public hearing at 6:30pm on the Amendment to the current 20/21 Budget Amendment. Discussion. Clerk stated there were no written or oral objections. Mayor closed the meeting at 6:32pm. Wellik/Frerk moved to approve resolution #668 on amending the 20/21 current budget. Discussion on Nuisance abatements in town. Possibly utilize Lions club for the minor yard cleanup. Mayor said for court ordered cleanup he will contact a few places to help with removal and storage. Discussion on new abatements. Council will compile a list of residents that need a courtesy letter. Per previous utility reports city employee Tony Higgins requested closed session. Mayor called to go into closed session per Iowa Code Iowa Code Section 21.5(1)(i) at 7:10pm. Mayor called to come back into regular session at 8:01pm.
