Dewey/ Minkler moved to approve boiler rebate for Lutheran Church in the amount of \$1600.00. All ayes.

Mayor discussed with council that he received a call from the DNR from an anonymous caller that the tree pile was burned. Mayor stated he will take the responsibility for it, he thought everything was ready to go. DNR wants the plan for future burns, discussion on ways to move forward.
