The City Council of the City of Rolfe met on June 9, 2025, at 5:30 p.m. at the community center. Mayor Jim Pentico called the meeting to order. The Pledge of Allegiance was followed by roll call. Present were Treasurer Sindergard; Council members Al Minkler, Rob Jackson, Dan Allen, Aaron Cox, Lana Pratt via phone; and several citizens. Absent was Clerk Henderson.

Mayor reviewed all the tree removal bids and made the phone calls as requested by council. Company #5, Schwebach Tree Service was awarded the contract. Cox/Allen, all ayes. Rolfe Public Library's new director was introduced to the council. Willa Casstevens started her role on June 2, 2025. Annual membership for Rolfe Betterment, Inc. was approved by Cox/Jackson, all ayes. Keep Iowa Beautiful Hometown Pride Program payment will be paid half by the City and half by HTP. Cox/Jackson, all ayes. Swimming pool is still getting attention. No opening date has been set yet.
