ROLFE REGULAR COUNCIL MEETING Monday, May 12, 2025

The City Council of the City of Rolfe met on May 12, 2025, at 5:30 p.m. at the community center. Mayor Jim Pentico called the meeting to order. The Pledge of Allegiance was followed by roll call. Present were Clerk Henderson; Treasurer Sindergard; Council members Al Minkler, Rob Jackson, Dan Allen, Lana Pratt, and Aaron Cox; Utility employee James Perry; Sheriff Nelson; and several citizens.

Cox/Allen, all ayes, approving the consent agenda including agenda, minutes from 4/14/25, 4/28/25 meetings, and bills. Motion carried. The special animal permit at 607 Locust St. was presented again, this time with a doctor's note recommending allowing these goats for emotional support animals. After discussion, Allen motioned to approve no more than two goats, Cox seconded. Minkler, Jackson, Allen, Cox, all ayes. Pratt nay. Permit approved. A building permit will be turned in to extend the fencing for said goats.

Treasurer Sindergard presented the March Treasurer's report. Allen/Jackson, all ayes. No comments from the City Clerk. The residents on Circle Dr. have brought up adding a "Dead End" or "No Outlet" sign to Pratt. This will be on the next meeting's agenda to take action on. Mayor reported the request for bids for tree removal have been sent out. Greater Rolfe Days will be July 11th-13th, 2025. Nothing to report from the City utility worker. There were six citizen complaints received. Three were dogs, one on chickens, and two on nuisance properties. Angie Harrison spoke to the Council about a large tree near 407 Elm St. in the City right-of-way. She asked for the tree to be removed. Council would prefer some barricades to be placed there warning pedestrians since the tree is in good condition. Citizens' comments included Barb Bennett and Wendy Panbecker asking to renew the partnership between Hometown Pride and the coach Margo Underwood. Annual membership is \$880 but was removed from the budget due to cuts.

Sheriff Nelson reported no issues. A public hearing has been set for May 28, 2025, 5:00 pm at the Rolfe community center to approve the FY25 Budget Amendment. Allen/Cox, roll call vote Pratt, Cox, Allen, Jackson, Minkler, all ayes. Action was taken on Hometown Pride's request to continue with Coach Underwood. Pratt motioned to pay at least half of the annual membership, with the Hometown Pride committee possibly paying the other half. Allen seconded, all ayes. A walk-up window will be installed in City Hall, replacing the large window between the hallway and City Hall. Park Board has approved this project. Allen/Cox, all ayes, to move forward and obtain pricing. 2024 Water Quality Report showed no violations. Allen/Cox, all ayes to approve. An increase in the credit card spending limit was asked for. Current limit is \$2,000 and Council approved increasing that to \$7,500. Allen/Cox, all ayes.

The older Dodge pickup will be taken over to the Sale Barn's next sale. Allen/Cox, all ayes. Mayor is still working on the paperwork for a loan for a new fire truck. A spreadsheet was handed out showing different loan repayment scenarios. He will continue the process. Nuisance abatement court will be held on 5/21/25. Mayor is working on a process for tracking payments owed to the City for infractions. A question arose about the City discharging from the lagoon to Pilot Creek. This was confirmed by Perry.

Allen/Cox moved to adjourn at 6:25 p.m. All ayes.
